1. Who We Are

2. The Information We Collect

We collect the following personal data directly from you:

- Name
- Email address

- Volunteer interests and skills and availability

3. Why We Need Your Data (Lawful Basis)

Under the UK GDPR, we must have a "lawful basis" for using your data. We process your information based on:

- Consent:** You have given us clear permission to contact you about volunteering and development updates
- Legitimate Interests:** It is necessary for our organisation to manage volunteer outreach effectively.

4. How We Use Your Data

We use your information only to:

- Contact you with updates relating to housing developments in Burnham on Crouch
- Contact you regarding volunteer opportunities.
- Match your skills with our current needs.
- Maintain an internal record of supporters.

5. Sharing Your Information

We will **never sell** your data. We only share your information with trusted third-party service providers (e.g., email platforms or secure databases) strictly to help us manage our communications.

6. Data Retention

We will keep your personal data for 5 years or until you ask us to remove it. Once this period expires, we will securely delete your information.

7. Your Data Rights

In the UK, you have the following rights regarding your data:

- Right to Access:** You can ask for a copy of the data we hold about you.
- Right to Rectification:** You can ask us to correct inaccurate information.
- Right to Erasure:** You can ask us to delete your data (the "right to be forgotten").
